Meet the South Carolina Ports Authority's newest inland Port in Dillon, S.C. serving the Eastern Carolinas. Located along I-95, Inland Port Dillon gives cargo owners, including shippers of refrigerated cargo, a powerful new tool to optimize their supply chain.

Address: 111 West Fairfield Road, Dillon, S.C. 29536. Located just off US Highway 501. Exit 190 off of Interstate 95.

Operator: Owned and operated by South Carolina Ports Authority.

Terminal Operating Hours: Open for receipt/delivery of containers 6:00 AM - 6:00 PM, Monday-Friday.

Trucking: TWIC card not required for entry. Drivers and trucking firms must be registered and compliant in the IANA/UIIA database.

Chassis and M&R: CCM chassis pool and M&R operation at a site adjacent to the inland port terminal.

Reefer: Container Maintenance Corp. will operate a reefer service area at a site adjacent to the terminal. Pre-tripping, washing, monitoring, and M&R services will be provided for reefer equipment.

Operating Essentials

Export BCOs: You will receive one Dillon-origin rate from your ocean carrier which includes all terminal fees in Dillon, CSX rail transit to Charleston, delivery to container terminal, plus international shipping to the destination. Please note that Inland Port Dillon is expected to have ample empty equipment to power your export operation.

Match Back: SCPA will be actively working to match empty containers in Dillon with exporters in the region.

Site Location: Inland Port Dillon is located within a prime 3,400-acre industrial site and is in close proximity to I-95 and affordable land for development. Spec buildings are available in the area. If you are interested in locating an export consolidation center, an import distribution center, or an advanced manufacturing plant, please contact our economic development office.

Import BCOs: You will receive one rate from your ocean carrier which includes shipping to Charleston, SCPA-provided dray to local CSX Intermodal ramp within 24-hours of becoming available (assuming the box is released by Customs, EIR is in order, and the box is physically on the marine terminal), rail transit to Dillon, and SCPA handling & facilitation fees in Dillon.
